#### **Parental consent**

The parents or legal guardians of each student agree to the participation of their sons and/or daughters in all activities and excursions organized by AEC without the need for prior notification from the course management. #### **Specific Conditions**

- 1. AEC must be informed of any relevant medical conditions on booking.

- 9. AEC is not responsible for loss or theft of belongings. We recommend that students take out extra personal, medical and baggage insurance.
- 10. Non-EU students must take out private medical insurance.

#### Visas

Visas are not required of EU nationals. If you are coming from a non-EU country, you should apply to your nearest Irish Embassy for your student / visitor visa. We will send you a letter of acceptance for your course that you may submit to the Irish Embassy along with relevant documentation.

#### Liability

AEC shall have no liability to the student for any loss, damages, costs, expenses or other claims for compensation connected to the student's participation in the programmes provided by AEC except in relation to death or personal injury caused by the negligence of AEC or its servants.
